From the North

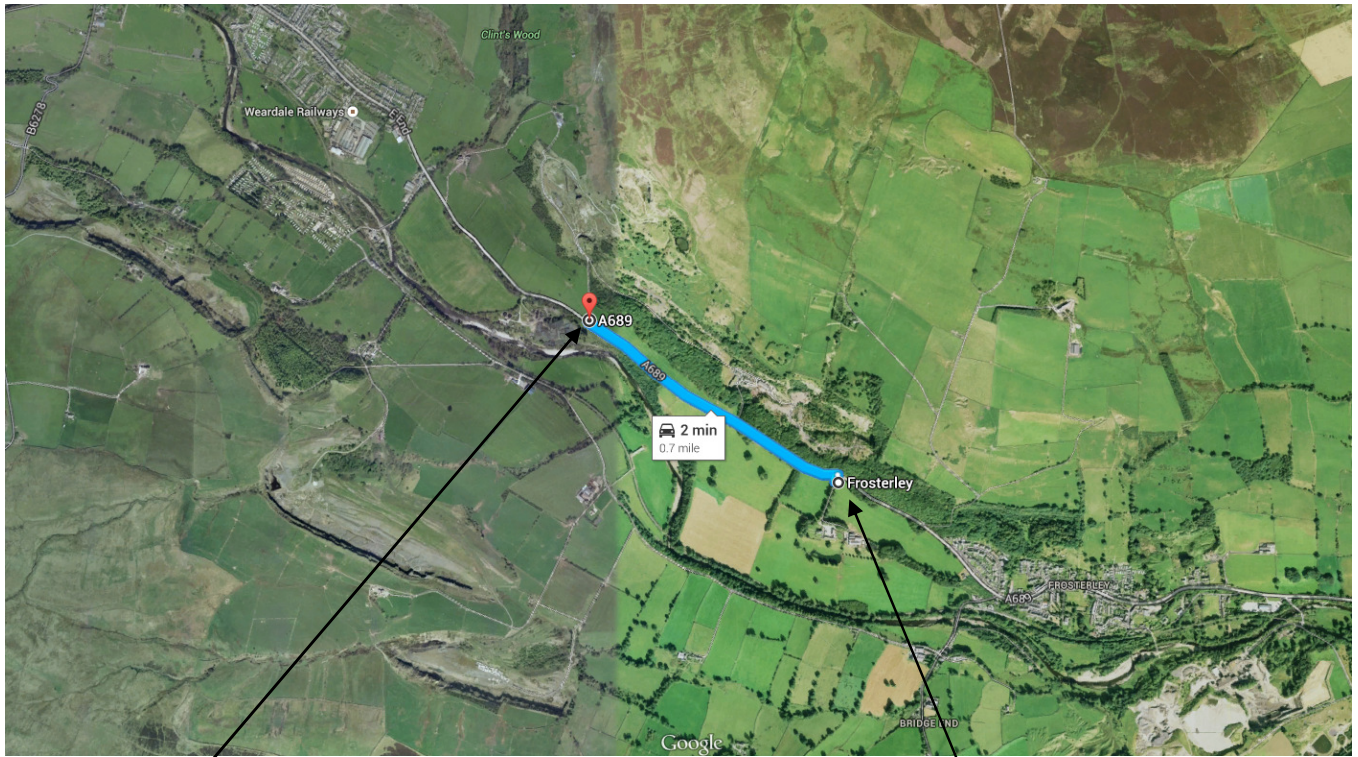
