A Club Restricted Trial. Round #2 of the 2017 Bradford & D.M.C. "Closed to Club" Championship Series.

**ANNOUNCEMENT:** Bradford & District Motor Club Limited will organise a Club Restricted Trial on 26<sup>th</sup> February 2017, for solo motorcycles, run under the National Sporting Code, Standing Regulations of the ACU, the Yorkshire Centre Rules current at the time, the following Supplementary Regulations and any Final Instructions issued for the meeting.

**ELIGIBILITY:** Restricted to all registered members of Bradford & District Motor Club Limited.

All riders and passengers must hold a current ACU/SACU Trials Registration Card or ACU/SACU Competition Licence. Any rider or passenger from another FMN must produce a licence issued by their FMN, together with start permission and proof of personal accident insurance.

**MACHINES:** Motorcycles as per NSC Appendix D Category 1, Group A1 Solos and TSR 8.

**CLASSES:** Adult: Expert, Intermediate, Novice, Clubman "A", Clubman "B", plus Youth Classes: A, B, C, & D. There will also be an Adult Beginners class & a Youth Beginners class.  
**(Gradings & class eligibility will be as per Yorkshire Centre ACU rules).**

**ENTRIES / FEE:** Entries, which must be on the official form provided & accompanied by **the correct fee**, will be taken on the day, up to one hour before the start.

### **Entry Fees: -**

For youths and for those entering to ride the "Beginners Course" the entry fee is **£10**.

For adults entering to ride any course other than the "Beginners Course", the entry fee is **£15**.

**RESULTS:** Will be posted on the club website; [www.bradfordtrials.com](http://www.bradfordtrials.com)

**AWARDS:** No awards are given at individual events in this series of trials but class points are awarded & these will count towards the Bradford & D.M.C. "Closed to Club" Championship Series, for which (subject to adequate participation) awards will be presented.

**COURSE:** All on private land; 4 laps of 10 sections. (However, the "Beginners Course" will be 4 laps of 8 sections).  
A lap will be approximately half a mile in length.

The sections will have the following routes; the "Main/Hard" route, a Clubman "A" route (which will use the main route on some sections & the Clubman "B" route on other sections), a Clubman "B" route and an even easier route for beginners.

**N.B. Riders younger than the "C" Class age group, as defined in TSR.1, will not be permitted to ride either the "Main/Hard" course, or the Clubman "A" course.**

The course will be closed by a "Backmarker", or as otherwise announced on the day in "Final Instructions".

**METHOD OF MARKING & TIES:** As per TSR 22A; stop permitted. Ties will be resolved as per TSR 23.

**PROTESTS:** Protests as per National Sporting Code of the ACU, section 10.04

**OBSERVERS:** Each "Official Observer" will be paid £10, either during, or at the conclusion of the event.

**ENTRY DECLARATION:** I the undersigned apply to enter the event described above and in consideration thereof: -

- I declare that I have had the opportunity to read, and that I understand the National Sporting Code of the ACU, the ACU Standing Regulations, such Supplementary Regulations as have or may be issued for the event, and agree to be bound by them.
- I declare that I am physically and mentally fit to take part in the event and I am competent to do so. I confirm that I understand the nature and type of event I am entering and its inherent risks and agree to accept the same notwithstanding that such risks may involve negligence on the part of the organisers or officials.
- I confirm that I am not currently suspended from ACU permitted competition or on the ACU Stop List as a result of incurring a Concussion injury.

I understand that this form may be used in litigation as evidence that any serious injury will be principally the result of my voluntary decision to engage in a high risk activity.

- I consent to the collection and retention of my personal information by the ACU.
- I confirm that the machine(s) as described below which I shall participate on shall be suitable and proper for the purpose. I confirm that I am eligible to compete on the machines for which I have entered.
- I confirm that if any part of the event takes place on a public highway, the machine(s) described below shall be insured as required by the Road Traffic Acts, or equivalent legislation, and that they will comply with the regulations in respect thereof.
- I accept responsibility for any items borrowed from the Organiser during the course of the event. These items include but are not restricted to (safety clothing, transponders, accessories). I understand that I am liable for the cost or replacement of any items lost or not returned and non-payment or non-replacement of items borrowed may affect my entry into subsequent events.
